Instructions to the Candidates for CAP Round-III

All the Maharashtra State Candidates who are eligible for CAP Round-III (Counselling Round) to be conducted from 29th Aug 2008 to 30th Aug 2008 are hereby informed to follow the following instructions carefully.

- **Eligible candidates must report in-person at the venue of “Center of Admission” in order to secure admission in this round of admission strictly as per the notified schedule. Candidate who reports late will not be allowed to participate in this round.**
- Candidate is required to pay processing fees of CAP Round-III, Rs.100/- in cash at the Center of Admission and obtain a receipt for the same.
- The candidate will report as per schedule at the **Center of Admission** along with the necessary original documents and carry part payment of non-refundable fees of **Rs.15,000/- in cash Or in the form of DD/Bankers Cheque drawn in favour of “The Principal, Govt. College of Pharmacy, Aurangabad” Payable at Aurangabad.**
- Eligible Candidates who report to the Admission Center will be offered admission to seats available at that point of time as per the inter se merit of candidates.
- Candidates who secure admission in this round must confirm the admission on the spot by paying non-refundable fees of Rs.15,000/- (in cash/DD/Bankers Cheque) and on producing necessary documents in original for verification.
- The **Center of Admission** will update the confirmation of the candidate’s admission on DTE website and issue the provisional admission letter to the candidate immediately.
- Candidate will have to report to the respective Institute for paying balance fees (i.e.Total fees **less** Rs. 15,000/-) along with all required original documents as per notified schedule.
- If the candidate fails to report to the Institute and pay the balance fees on or before the last date of reporting at the Institute then the candidate shall lose claim on the allotted seat as well on the Rs.15,000/- paid by the candidate at the **Center of Admission.**
- **All the backward class category candidates are required to pay the non-refundable fee of Rs. 15,000/- . This fee will be refunded back to the backward class candidate by the institute if he/she confirms the admission at the institute.**
- Only one Parent will be permitted along with the candidate at the center of Admission.
