

**Centralized Admission Process (CAP) for Pharmacy Course:**

For the academic year 2008-09, the Competent Authority shall conduct total Three (3) rounds of Centralized Admission. The CAP shall consist of first two (2) rounds of Centralized Allotment wherein eligible candidates (both Maharashtra and OMS) will fill separate/fresh Online Option forms for respective rounds. Third round of CAP shall be conducted by way of counseling only for the eligible Maharashtra State candidates.

Candidates who have filled in and confirmed the aforesaid Online Application form for Admission to Pharmacy course at ARCs and who have been assigned a merit no. shall be eligible to participate in the CAP.
