**Third Round of Centralised Allotment Process (CAP Round-III) (Admissions for
the Academic Year 2006-2007 to the First Year of Four Year Full Time Degree
Courses in Engineering / Technology)**

Reference: Engineering/Technology ADMISSION NOTIFICATION issued by the Directorate of Technical Education vide No. 2A/ADM/FE CAP III/2006/1413 dated 19th Aug., 2006

With reference to the above-mentioned Notification published by this Directorate, eligibility criteria for CAP Round -III is revised as below.

Eligible Candidates : All Maharashtra State Candidates, whose names have appeared in the Maharashtra State Candidates' Merit list of CAP Round -I and who satisfies any one of the following criteria are eligible to apply for this CAP round-III.

1. All such candidate(s), who were allotted a seat (Maharashtra State Allotment or AIEEE Allotment) in CAP Round-I and failed to confirm their respective admission(s) due to any reasons.
2. All such candidate(s), who have confirmed their respective admission(s) of CAP Round-I (Maharashtra State Allotment or AIEEE Allotment) and subsequently cancelled the same on or before 22nd August 2006.
3. All such candidate(s), who have not obtained any allotment (s) (Maharashtra State Allotment or AIEEE Allotment) in CAP Round -I And CAP Round -II (or both Rounds).

Following candidates are not eligible to apply for CAP Round-III :

1. All such candidate(s), who were allotted a seat (Maharashtra State Allotment or AIEEE Allotment) in CAP Round-I and confirmed their respective admission(s) and are on the roll of the respective institute(s) as on 23rd August, 2006.
2. All such candidate(s), who were allotted a seat (Maharashtra State Allotment or AIEEE Allotment) in CAP Round-II, irrespective of the fact as to whether such candidate(s) have confirmed their respective admission(s) or not.
