**Fourth Round of Centralised Admission by Personal Counseling  
(Admissions for the Academic Year 2006-2007 to the First Year of Four Year Full Time  
Degree Course in Pharmacy)**

In pursuance of the orders passed by the Hon'ble High Court, Mumbai, in Writ Petition (L) no.1862/2006, dated 11<sup>th</sup> August 2006, the Directorate of Technical Education is conducting **Fourth and last** Round of Centralised Admission by '**Personal Counseling**' at the **Auditorium of Govt. College of Engineering, Aurangabad** for the vacant seats that may be available at the start of fourth Round.

**Eligible Candidates:-** All Maharashtra State Candidates, whose names have appeared in the Maharashtra State Candidates' Merit list of CAP Round-I and who were eligible to apply for CAP round-III, except the following that are hereby held '**Not Eligible Candidates**', are eligible to apply for this round of Centralised Admission by Personal Counseling.

**Not Eligible Candidates:** In addition to the not eligible candidates, notified in the notification No.2A/ADM/PHARM CAP III/2006/1498 dt. 31<sup>st</sup> August,2006, issued by this Directorate, all such candidate(s), who were allotted a seat in CAP Round-III, irrespective of the fact as to whether such candidate(s) have confirmed their respective admission(s) or not are not eligible to apply for this fourth round of Admission (by Personal Counseling).

**Seats available:** All seats from all the Institutes participating in Centralized Admission Process that is being conducted by the State Government authorities (within the respective sanctioned intake capacity of each of such Institutions) that have remained vacant, on account of whatsoever reason, before the start of Round-IV.

**Further it is specifically brought to notice of all the candidates that,**

- a) Round-IV will be conducted for Maharashtra State candidates only.
- b) There shall be only one stage of admission in this Round-IV that will be conducted by way of personal counseling.
- c) Seats available shall be allotted solely on the basis of inter-se merit determined as per the MHT-CET-2006 merit list without any reference whatsoever to the category of the candidate(s) (open /reserved/male/female) or the category to which the vacant seat belongs.
- d) All available vacant seats shall be treated as 100% State Level seats.

**General notes:**

1. Candidates are required to report at the Center for Counseling and pay **Rs.100/- in cash** at the Registration counter, as a processing fee of Round-IV, as this round was not contemplated and hence are recovered before the holding of this round.
2. All the Candidate(s) to whom seat(s) will be offered in this Round-IV, will have to accept such allotment and confirm the admission by depositing non-refundable (under any circumstances) amount of **Rs.14,000/-** on the spot towards advance payment of part of fees. This amount is to be deposited with The Principal, Government College of Pharmacy, Aurangabad by way of cash or DD drawn in favour of **"The Principal, Government College of Pharmacy, Aurangabad"** payable at **"Aurangabad"**. The amount shall be remitted to the respective Institutes/Colleges by the undersigned. The candidate while completing admission formalities at the respective college at which admission is so granted, will be required to produce the receipt issued by the office of The Principal, Government College of Pharmacy, Aurangabad and deposit the balance amount of fees with the Institute.  
In case if, the candidate fails to report with the Institution at which such admission is granted on or before the last date of reporting set out hereunder and complete the formalities etc. as set out hereinabove, not only the admission so granted shall stand cancelled but also the amount of **Rs.14,000/-** so deposited will stand forfeited.
3. **Seats remaining vacant at the end of Round-IV, shall be filled by the respective Institutes at the institute level. Guidelines for filling up of vacant seats will be made available on the official website [www.dte.org.in/ph2006](http://www.dte.org.in/ph2006).**
